WAIVER & HOLD HARMLESS AGREEMENT

I agree to abide by the regulations of the club governing the use of the crane lift as detailed below, including the work shifts required as part of the lift cost. I also agree that the City of Burlington, the City of Hamilton, the Hamilton Port Authority, the LaSalle Park Marina, the Burlington Sailing and Boating Club, its officers, members, employees or staff, subcontractors and helpers will not be held responsible for personal injury, loss, damage or destruction to personal property, however caused, during any part of the lift-out, storage or lift-in of any vessel.

Regulations and Conditions

- A. The lift is available solely to members of the Burlington Sailing & Boating Club.
- B. Maximum length accommodated is 37.5 feet. Exceptions are subject to review by the Facilities Director.
- C. To follow all safety and environmental guidelines.
- D. To provide 4 long lines for control of the boat during lift.
- E. To clean-up any garbage or mess created by the lift process, empty paint cans and paraphernalia.
- F. To follow the directions of the designated lift director and crane operator.

RATES:

\$100.00 for a mobile trailer boat that is moved by a vehicle to behind the crane at time of lift.

\$150.00 for boats lifted from a cradle on the pier, or boats on a trailer, which require the crane to travel to pick the boat up and move it to the water.
